**RULES AND REGULATIONS**

Updated June 2018

## **1. General.**

1.1 Large planned events that are advertised and open to the public (ex. fair, tournaments, public gatherings, etc.) are required to submit an application for review and will require insurance. Please contact the Port to discuss your event at (360)673-2325.

1.2 Events without prior authorization will be asked to leave the grounds. The picnic pavilions are available first come first serve and are unable to be reserved.

1.3 All equipment must be removed after each use of the parks.

1.4 Users will be responsible for cleaning restrooms/emptying all garbage cans daily/picking up litter during events.

1.5 Disorderly conduct, abusive language, noisy disturbances or disregard of these rules and regulations will be grounds for your immediate removal from the park by police, security, or authorized Port personnel. It is at the Port's discretion if you will be allowed back on the property.

1.6 Children shall not be left unattended in the park.

1.7 No overnight camping permitted.

1.8 Haydu Park is open for public recreation from sunrise to sunset. (Except by permit)

1.9 Weapons and dangerous objects may not be used in the park.

1.10 Park users will be held responsible for conduct that violates Port regulations and causes damage to the park or its equipment.

1.11 To ensure everyone's safety dogs must be on a leash and in control at all times. There are no pets allowed at Haydu Park except those associated with events with prior authorization.

1.12 The Port is not responsible for accidents, injuries or loss of property by fire, theft, wind, flood, or other natural acts which are beyond their control. Equipment furnished on the grounds is solely for your convenience and shall be used at your own risk.

1.13 The Port is not responsible for any personal injury from using playground equipment. Participants use the equipment at their own risk.

1.14 You should immediately notify the Port of Kalama of hazardous conditions in the park or situations that violate these rules and regulations.

1.15 Golfing is strictly prohibited in the parks.

## **2. Automobiles and Motorized Vehicles**

2.1 Motor vehicles shall be parked only in designated areas. Motor vehicles parked elsewhere or on the grass will be towed at the owner's expense and owner may be permanently banned from the parks.

2.2 Auto and boat repairs are not allowed anywhere at any time on park property.

2.3 Overnight parking permits are required and available at the Port administrative office during normal business hours.

2.4 Please obey the posted speed limits. Use extra caution for children and pedestrians.

2.5 Bicycles and other types of non-motorized vehicles must be used properly, safely and without the possibility of injury to others.

2.6 Skateboards/Roller-skates/Rollerblades are not allowed in the parks.

2.7 Disturbing or careless operation of motorcycles, automobiles or other types of motor vehicles will be grounds for removal from the parks and/or citation by police.

2.8 Vehicles and boats may not be parked with for sale signs on Port property.

2.9 Overnight parking of RV's and Campers and unattended boat trailers are not allowed.

## **3. Park Buildings and Facilities**

3.1 Park Buildings and facilities are provided for your privilege and convenience. You have a responsibility to use the facilities with respect for others and to keep them neat and clean. Any irregularities should be reported immediately to the Port.

3.2 All materials including tape, streamers, banners, etc., must be removed thoroughly after each event.

3.3 No signs shall be posted on the trees or shrubs, nor can any nails, screws, or other foreign objects be driven in to the structures.

3.4 Nothing greater than 5 lbs shall be attached to or hung on any structures for any reason.

#### **4. Solid Waste Disposal and Fire Protection**

4.1 Garbage and trash must be placed in the proper receptacles.

4.2 No person shall bring any non-park generated garbage into the park for the purpose of discarding or disposing of such garbage or other refuse.

4.3 Absolutely no fires are allowed on Port property.

#### **5. Vegetative Protection**

5.1 No person other than a duly authorized Port employee in the performance of his or her duty or persons participating in Port approved activities shall dig, remove, destroy, injure, mutilate, or cut any trees, plants, shrubs, blooms, flowers, or any portion thereof growing in the park.

5.2 Trees and shrubs are not to be climbed, hung-on, or used as poles for game, nets or swings.

5.3 No staking of tents, nets, etc., of any kind into the grounds is allowed.

#### **6. Assumption of Risk & Port Immunity**

**The Port is making this park and its recreational facilities available to the public free of charge. The Port is therefore not liable for any injury to park users as provided under RCW 4.24.210. By using the park, all users recognize the inherent risks with outdoor recreational and sporting activities. The Port does not supervise or monitor any of the events or activities in this park. Each park user agrees to assume full responsibility of risk for injuries that may occur in conjunction with use of this park.**
